Successful Scholarship Applicant

Successful scholarship applicant(s) will receive a Letter of Offer, detailing the scholarship benefits. If you do not wish to accept a scholarship that has been offered, please advise us immediately in writing. The applicable school fees and deposit will be stated on the Letter of Offer.

Scholarship Offer & Validity

The scholarship committee comprises Tan Sri Datuk Ter Leong Yap, Executive Chairman of Sunsuria Berhad, Mr. Neil Hawkins, Founding Principal of Concord College International School and Dr. Phil Outram, Executive Principal of Concord College International School who will meet and interview all shortlisted candidates and meet to determine the final scholarship awards. A member of the relevant academic team may also be part of the selection process, depending on the nature of the award application.

The Refundable Deposit as stated on the Letter of Offer must be received by the school **on or before the Last Date to Accept the Offer**. Payment must be made in Ringgit Malaysia.

The offer of place and scholarship will no longer be valid if:

- the deposit is not received by the School on the **Last Date to Accept the Offer** as stated on the Letter of Offer or;
- the offer of place and scholarship is declined.

Eligibility Requirement

All scholarships are awarded on the basis that your child will maintain full time enrolment in their approved year group. Your child's scholarship will be terminated if their enrolment status changes, for example if they discontinue their school studies at CCIS.

Terms & Conditions

This document outlines the Terms and Conditions for Concord College International School (CCIS) scholarships. It is mandatory to thoroughly review and understand these Terms and Conditions. By accepting a scholarship from CCIS, it is implied that you have read and agreed to adhere to these terms.

- Please be aware that these Terms & Conditions supplement the Terms & Conditions outlined in the 'CCIS Admission' form regarding enrolment and admission. Acceptance of the scholarship must be confirmed by **before the Last Date to Accept the Offer'**
- CCIS holds absolute discretion in accepting scholarship applications. The school reserves the right to decline any application without providing justification for the decision.
- Successful scholarship recipients are not entitled to receive multiple awards or CCIS waiver schemes within a single academic year.

- CCIS Scholarships is granted for the entire duration of a recipient's Secondary School education including A-Level (Year 12 and 13) provided that the recipient maintains excellent academic standing, positive behaviour, and consistent contributions to academic and/or co-curricular activities. The school reserves the right to withdraw this offer if the recipient fails to achieve these conditions.
- Scholarship recipients are required to serve as official School Ambassadors for the duration of the award. Scholars are expected to positively represent and promote the School at events, open days, marketing activities, media features, and outreach initiatives as reasonably requested. This may include participation in interviews, photo/video shoots, testimonials, school visits, and engagement with prospective students and families.
- Scholarship recipients are required to enroll at Concord College International School for Academic Year 2026/2027

Scholarship Termination

- CCIS reserves the right to terminate a student's scholarship if they:
 - Fail to meet the terms and conditions of the scholarship;
 - Fail to comply with enrolment and admission terms & conditions;
 - Fail to maintain satisfactory academic progress;
 - Are suspended or excluded from school during their course of study.
- Provide incorrect, false, or misleading information during the scholarship application process or after receiving a scholarship offer. In such cases, the school may request reimbursement of part or all the awarded scholarship amount.

Scholarship Consent Policy
